The Pennsylvania Radio Relay League (PRRL) has been born

The words above are quoted directly from an email message that Pip WB4FDT recently sent me. I first met Pip about 20 years ago when he was living in north LA. Over **WA3VJB POSTS:** Of course having outside observers would be a good thing. I see no basis to support the idea that it would contaminate the atmosphere somehow. As for support among dues-paying participants, it was a move toward open discourse that prompted me to resume paying those subscription fees, case in point. Albert W3MIV said

his rather interesting career WB4FDT has worked for both the FCC and the ARRL. In addition to posting Pip's comments above, I would really like to know the following: Are there any "rank and file" League members (with the obvious exception of W3MIV!) who truly believe that having open Board meetings is a bad idea? As I recently pointed out, the Board meetings of the National Rifle Association are open. If the NRA can conduct its Board meetings in public, then surely the ARRL can allow a limited number of League members to ob-

What a breath of fresh air that they not only asked their constituents what they thought of various issues, but they ALSO vowed to publish the findings !!! Shocking !! And the world didn't end. It probably scared the s\*\*\* out of certain members of the Backroom Club in Newington to see substantial support for facets of the hobby they've been neglecting.

Members and nonmembers would have access as to how things are done and the openness could very well contribute to a larger membership. Usually changes thru the years beginning with incentive licensing have caused many to leave the ARRL. The change from closed to open BOD meetings would have the opposite effect. Certainly no member would drop his membership due to this change. survey of amateurs that was rolled out in Atlantic, Great [others] point out, it would be a win-win situation if the ARRL Board of Directors would move toward open meetings.

With the exception of W3MIV, I don't recall reading any negative reactions so far on this thread to any of the six issues in my campaign platform. The hams who I've talked with in person at clubs and hamfests since beginning my campaign have certainly been very receptive to my platform. If the changes I've proposed are adopted by the Board of Directors, no current members will drop their memberships and a significant number of former members will join again.

I want to express my appreciation again to all the hams who have posted comments here. At this time I particularly want to acknowledge the very strong show of support from my fellow members of the Fist and Mouth Contest Company (K5FMC): K4JRB, N5NA, K5QK, WC5N, and W5EW. (Three of these guys will actually be able to vote for me, assuming K5QK renews his membership before the ballots are mailed out!)

**WB0WR POSTS:** It will only be changes like K5MC has proposed for the BOD meetings that will bring me back into being an ARRL member!

It is the "circle the wagons" mentality of the ARRL that has put it 180deg out of touch with the amateur community as their actions over the past decade has highlighted.

From their stance on bandwidth regulation, to unrestricted encryption being used on the ham bands, to recommendations like 20khz wide data signals on the HF bands to facilitate internet web browsing, to pushing amateur radio to become the next AT&T they are simply out of touch.

Clinging to the notion that BOD meetings have to be secret in order to accomplish things is just one more symptom of a group that is insular and paranoid. It smacks of back-room deals and good-ol-boy politicking.

There is not a single School Board in this country that does not have to continually address issues that are divisive, difficult, and complex. Yet they do so \*every month\* **in public**. They even allow the public to speak their mind during the meeting. Most School Boards understand that the Board itself is \*not\* always the most knowledgeable entity on specific subjects and that they don't always have the only ideas worth considering. Outside input is vital. That is the one big thing taught in leadership classes today -- the leaders don't always have the best ideas. What we see from the ARRL today is the top-down mentality from 50 years ago -- "by Gosh! We know best and we'll \*force\* everyone to follow our ideas!"

Sunshine is the best disinfectant for a group that takes money from others in return for services, including as a representative to international rule making bodies.

**W3MIV POSTS:** I wish Mickey all the luck in the world. I do not in any way disparage his sincerity or his desire to work to improve the League and its BOD. What I doubt is his discretion in coming on QRZ and proposing a platform that has zero chance of acceptance by a majority of the current Board, and then using this platform as a vehicle to disparage a serving Director in another Division.

I have the strong feeling now that Mickey's election, if successful, will not materially contribute much worthwhile since I believe he has branded himself badly and will likely be viewed as a loose cannon rather than as a potential team player. The ways of Boards do not vary much from one to another or from one type of organization/institution to another.

In his eagerness to gain support among some of the participants on this forum (which do not constitute a majority of the Delta membership, which approximates 8k or so hams), Mickey has shot himself in the foot. I regret that, but cannot change it.

**KC4RAN RESPONDS:** He can suggest that the board votes to see whether they'll open the meetings or not. Hopefully the procedural elements surrounding that 'suggestion' (i.e. rules of parliament or whatever other) will be recorded in the minutes in such a way to show that it happened. If someone 'seconds', then we can see who did, and at least know there's one other member either in support or who wants to see it come to a vote, even if it fails.

If it doesn't come to a vote, we know there's something terribly wrong with the entire board. Each division should be made aware of this. If it comes to a vote, then those that vote "no" should be prepared to defend their position, and each no voter should be challenged on this position, and it should be publicized to their division.

Transparency is key here. There are too many questions surrounding many of the key ARRL positions and how they came to be.

**K5MC POSTS:** Perhaps W3MIV will tell the rest of us here whether any current ARRL Directors have actually told him that they are "enraged" by my campaign platform or whether that is merely another opinion held by him. If it's merely his opinion, as I suspect it is, then W3MIV apparently thinks the current Board members are rather petty.

Perhaps W3MIV will also give the rest of us here his opinions as to why the National Rifle Association, unlike the ARRL, conducts its Board meetings in public rather than limiting attendance to Directors and Officers. Even W3MIV should be willing to concede the point that the NRA and the ARRL are very similar organizations in spirit - one is an advocate for gun owners and the other is an advocate for ham radio operators.

**W3MVI POSTS:** Sorry, Mickey, but I must aver that it is not any of the present Board members who is being "petty" in this thread. As to my opinion, it is just that, and were I privy to any "inside" information, I assure you I would not share it with any of you. That is the essence of confidentiality.

Mickey, I have been a Life Member of the NRA for more than thirty years, and I was an annual member for more than ten years before that. I go back a long way with the NRA, and I cannot agree that it is a "very similar" organization. The only true parallel is that both are membership organizations; beyond that, their missions are very different, as are their goals.

In the final appraisal, however, none of that matters: We are not here dealing with the NRA, but with the ARRL. We are dealing with an organization that has an established institutional bias and is subject to a hardened institutional memory. That is a fact that anyone running for office must take into account. Your "platform" stands at odds with most of that bias, flagrantly so on a few "planks." How well those "planks" play to the Delta crowd remains to be seen; how they will play to your fellow Directors in Newington, should you be elected, is entirely predictable. That you have chosen to let yourself be a tool in an attack on another Director speaks ill of your discretion, seriously so, as I have pointed out previously. It is one thing to set out on a very tough goal; but to make the matter even tougher by such a stupid (sorry, Mickey, but no other word suffices) faux pas puts your ability to handle the task in serious doubt.

I tire of posting the same old responses by the same old coterie of bashers. This will be my last. Let's plan to meet again after the election and compare notes; if you succeed, I shall raise a glass in salute, but also challenge you to meet again toward the middle of your term for an appraisal.

**K5MC POSTS:** Gee, Albert, it's rather amazing to me how a fellow NRA Life Member can't recognize how similar in spirit the NRA and the ARRL truly are. Based upon some of your other posts here, however, there's really no reason that I should be surprised.

There's also no reason for us to "compare notes" after the election. If I'm not elected to represent the Delta Division, I will congratulate the winner and will then happily return to my many other interests, both inside the hobby and elsewhere. If I am elected, I will work diligently to have the Board adopt as many of the changes outlined in my platform as possible and all you will have to do is read the minutes of the Board meetings for an appraisal of my performance.

Enjoy your time away from this thread. (Something tells me, however, that you will be back sooner rather than later.)


