

Why HR 607 will have no impact yet.

The problem starts with one simple word: Auction.

In February, New York's Congressional Representative Peter King proposed a bill to Congress, titled the Broadband for First Responders Act of 2011, also known as HR 607. The bill's purpose is twofold – to increase public safety spectrum by 10 megahertz, and to decrease commercial spectrum by the same amount. Even though this is a fantastic goal, there is a tiny flaw in the bill. And that is the sacrifice of 420-440MHz.

The bill promises all public safety "entities" between 170MHz and 510MHz will be moved to 700MHz – 800MHz, the "D Block" of spectrum. It also mentions our dreaded word, "Auction," on the following page. No less than ten years after the passing of the bill, the entire 70cm band, as well as the 450-470MHz public safety band, will be auctioned off by the FCC "through a system of competitive bidding."

Ironically, the FCC is also interested in auctioning the 700MHz D Block of spectrum, although there is no auction date or further information currently listed. With 440 auctioned to the highest bidder, radios able to transmit on the band will useless. The auction will also limit vital ham frequencies in an emergency. 440 is also the lowest frequency with fair propagation able to transmit video signals – something that could be vital after an emergency or natural disaster.

Even though it is a tremendous concern in the amateur community, the current status of the bill is amusing. Since February 10, when the bill was first introduced, it has been referred to the House Committee on Energy and Commerce, then referred to the Subcommittee on Communications and Technology eighteen days later. Since then, no action has been taken on the bill. No action, at least, from Congress. The ARRL has recently stated that amateur radio operators have sent over 13,000 letters opposing the bill, and Representative King has met with a group of amateurs discussing the bill. He has since stated he no longer favors placing the amateur bands in the bill. Replacement bands are still a mystery, however.

Although HR 607 has not yet passed, and could possibly never pass, there is still a chance 440 could be sold within the next ten years. As the ARRL wrote, keep your pen primed. You never know when you may need it. ¬

the facts HR 607

On February 10, 2011, Rep. Peter King (R-NY), Chairman of the House Homeland Security Committee, introduced H.R. 607, the "Broadband for First Responders Act of 2011," which has been referred to the House Energy and Commerce Committee (which handles telecommunications legislation). The bill addresses certain spectrum management issues including the creation and maintenance of a nationwide Public Safety broadband network.

As part of that network, the Bill provides for the allocation of the socalled "D-Block" of spectrum in the 700 MHz range for Public Safety use. HR 607 uniquely, provides for the reallocation of other spectrum for auction to commercial users, in order to offset the loss of revenue that would occur as the result of the allocation of the D-Block to Public Safety instead of commercial auction. H.R. 607 lists, among the bands to be reallocated for commercial auction within ten years of the passage of the Bill, the paired bands 420-440 MHz and 450-470 MHz.

The inclusion of most of the Amateur 70-cm spectrum as one of the replacement bands is a major problem. The 420-440 MHz band is not Public Safety spectrum and should not be included in any spectrum swap of Public Safety allocations.

While the ARRL and all Amateurs support the work of Public Safety and recognize their need for dedicated spectrum which would promote interoperability, the ARRL vigorously opposes HR 607 in its present form. HR 607 is a direct threat to our limited spectrum and the ARRL encourages all amateurs to appropriately voice their opposition to this bill. - ARRL

THE ISSUE

Effective today (6/17/11), the QRZ Callsign database is changing the way we serve callsign data to our web (browser) based users. These changes have been brought on by a steadily increasing number of automated systems that access the QRZ data in so-called hidden or stealth mode. Such systems create a significant load on the QRZ servers and in doing so, deprive ordinary users of the performance that they deserve.

Today's changes address these issues with a new set of constraints that we have developed with the goal of providing fast and fair access to all QRZ users. The following is a summary of what these measures mean:

• Callsign data, including name, address, and other QSL and logging information will be shown only to registered users of QRZ who are logged in at the time of the request. Guests that have not logged in will still see the callsign Bio page and pictures, but no callsign information will be shown.

• Registered users who are logged in will see the full detail on callsign pages.


• Ham users, i.e. those whose user name matches a callsign in our database, are limited to 150 callsign page lookups per day, not including their own callsign page.


• Non-ham users, i.e. users who aren't hams or don't have a username that matches one of our callsigns, will be limited to 25 callsign lookups per day.


• QRZ subscribers, of any type, are granted unlimited daily access to the QRZ callsign data. - QRZ

























RACES / ARES eQRM Urges All County Hams to Participate


